THE ORGANIZATION HAS ADAPTED NEW SOFTWARE TO ENABLE THE DETERMINATION OF ACCRUED COMPENSATED ABSENCES FOR VACATION AND SICK LEAVE PAY AND HAVE CHANGED THE METHOD OF RECOGNIZING THESE COSTS FROM WHEN PAID TO WHEN ACCRUED. IT IS IMPRACTICABLE TO DETERMINE THE PERIOD SPECIFIC EFFECTS OF THIS ACCOUNTING CHANGE, SO THE CHANGE HAS BEEN RECORDED AS A LIABILITY AS OF THE BEGINNING OF THE EARLIEST PERIOD FOR WHICH THE RETROSPECTIVE APPLICATION IS PRACTICABLE. ACCRUED COMPENSATED ABSENCES AS OF DECEMBER 31, 2010 ARE \$60,006. THE OPENING FUND BALANCE HAS BEEN ADJUSTED FOR ACCRUED COMPENSATED ABSENCES AS OF JANUARY 1, 2010 IN THE AMOUNT OF \$59,407.
